I have even heard comments such as "if we phase out fossil fuels, we will no longer have bad hurricanes". Which we all know is ridiculous. Messaging has to be clearer about the incremental impact that we contribute to as humans, superimposed on natural patterns. This will help avoid rabbit hole discussions trying to explain to someone why there is evidence the climate has changed in the past, long before we came on the scene or started using fossil fuels. As you noted in this great presentation, there are enough challenges to making progress without having to deal with these very basic "distractions" which interferes with moving ahead on impactful actions.

The Forest to Gulf region, nestled between North Central Florida's sandy ridges and coastal estuaries, wetlands and longleaf pine forest provide critical habitat for many imperiled species, including the eastern indigo snake and gopher tortoise. The region contains ecologically sensitive wetlands and river systems, lands important for groundwater supplies, family-owned timber and grazing lands, and natural area buffers that ameliorate risk of volatile weather and sea level rise. The Alachua Conservation Trust and over ten contributing partners will work with landowners and producers to implement a combination of permanent easements and land management activities to support existing habitat preservation and water quality goals.

Project partners have committed to purchasing carbon credits associated with project activities. Participating producers will receive a share of the proceeds and the balance will be reinvested in additional projects.
